



A Membership Platform Connected to Real-World Execution

BTS is a curated membership ecosystem designed to give participants structured access to real-world commodity execution without operating mines, holding inventory or managing logistics.

BTS does not mine gold.

BTS does not process gold.

BTS does not sell gold directly.

Instead, BTS connects its members to their own gold execution through OODL Marketplace (OMP), a live platform that executes, settles and records real commodity transactions.

BTS is access. OMP is execution. Raven is supply.

Where GODL Fits

The **Gold-Referenced** Utility Token

GODL is the gold-specific utility token used inside supported ecosystems.

For **BTS** members:

GODL provides gold-referenced pricing

GODL enables digital access to execution

GODL allows participation without ownership or custody of gold

What **GODL** is:

A digital reference unit

Priced against real gold transactions executed on **OMP**

Used for access, measurement and interaction

What **GODL** is not:

Not physical gold

Not an investment product

Not profit participation

Not redeemable for metal

Gold sets the reference. **GODL is the interface.**

The Execution Stack

How Gold Moves Through the System

Raven Minerals (Physical Supply):

- Licensed, on-the-ground operating partner
- Processes and supplies gold through compliant channels
- Handles production, processing, and physical delivery

OODL Marketplace (Execution & Settlement):

- Purchases gold from Raven
- Executes verified sales to approved buyers
- Records pricing, settlement, and transaction data

BTS (Member Access Layer):

- BTS acquires gold from OMP for trade purposes
- BTS members interact digitally via GODL
- All execution happens upstream, off-platform

Flow:

Raven → OMP → Trade Execution →
BTS Aquisition (OMP) → Member Access via GODL



From Vein to Ready Gold



This image shows the **gold vein*** in our active artisanal mine, material that already exists and is already being worked.

*A **gold vein** is the visible line or zone of gold-bearing rock that our miners follow to extract from the mine.

The image to the right is **run-of-mine ore**, extracted and ready for processing, representing real production. **Ore** is then extracted material from an active mine that will be processed to recover **gold**.



The image to the left shows local **crushing and processing** in action, where raw **ore** is converted into concentrated material suitable for **smelting**.

Processed gold concentrate being **smelted** on site as part of active execution.

Rough **22-carat doré bars** cast from smelting.



How BTS Members Access Gold Exposure (Without Holding Gold)

BTS members may acquire **GODL** within supported programs.

Through **GODL**, members can:

- Reference gold pricing derived from real OMP transactions
- **Interact with gold-linked value digitally**
- Avoid storage, insurance, transport or operational risk

Important **distinction**:

- **OMP buys gold from Raven**
- OMP executes and settles sales
- **GODL reflects pricing from that execution**
- BTS members interact via GODL, not via gold ownership

This is not speculation. It is structured access to execution-backed pricing. Execution is carried out on the ground in Tanzania, in partnership with **Raven Minerals Ltd.**, a licensed local operator responsible for in-country compliance, processing coordination and export execution.

Rather than relying on third-party reporting or remote supervision, operations are supported by our **permanent on-site presence** that actively oversees each stage of execution, including:

- Sourcing and handling of gold-bearing material
- **Quality control during processing and smelting**
- Gold doré production and preparation
- **Compliance with local regulatory requirements**
- Coordination for lawful sale or export

See Execution as It Happens: Inside BTS, Powered by GODL

BTS is built around **real execution**, not abstractions.

As part of the **BTS** platform's commitment to **radical transparency**, members are given direct visibility into each stage of the **90-day Earth-to-Asset cycle** that underpins **GODL** within the **BTS ecosystem**.

Throughout every cycle, **on-site video updates** are captured and shared as execution unfolds, **documenting mine production**, ore processing, **smelting** and preparation for sale exactly as they occur on the ground.

These are not retrospective summaries or polished recaps. They are **real-time glimpses into live execution**, filmed at source and released as milestones are reached.

Members can view previously **released execution footage** and follow new updates as each cycle progresses, providing a clear line of sight into how **GODL** is produced and managed within **BTS**.

This structure **ensures execution** is actively supervised, coordinated, and controlled in real time, rather than outsourced or observed from a distance. **BTS members** don't just hear about execution, **they see it step by step**, directly from the site.

For added convenience, **BTS offers an sell-back service**, allowing members to sell their **GODL** to **BTS** at the **prevailing daily gold spot reference price**.
